- 3. The ICC is required to initiate inquiry as prescribed under Section 11 of the Sexual Harassment of Women at Workplace (PPR) Act, 2013 as per DoPT, New Delhi OM No.11013/2/2014-Estt.(A-III) dated 16/07/2015 by calling upon complaint to provide detailed complaint along with all the relevant evidences ( Documentary or otherwise )
- 4. As per the guidelines the ICC shall meet at least once in every quarter even if no live case is available to review the preparedness and fulfill the requirement of the Apex Court's judgment in Vishaka case. The ICC shall be responsible for appropriate action in this regard.
- 5. The ICC will provide ,where necessary ,a special counselor or other support service including maintenance of confidentiality of the complaints and ensure time bound disposed / treatment and Redressal of complaints made by women employees /girls trainees/ and Trade Apprentices, etc. The ICC will be submit final report/s to the undersigned.
