Diploma (3 years duration) in Secretarial Practice / Modern Office Management from recognized University / Board or relevant Advanced Diploma (Vocational) from DGT with two years' experience in relevant field.

**OR**

NTC/NAC passed in Stenographer Secretarial Assistant (English), Secretarial Practice (English) trade with two years experience in the relevant field.

**\*Essential Qualification:** National Craft Instructor Certificate (NCIC) in "Office Management" Trade in any of the variants under DGT.

B.Voc./Degree in Electronics/ Electronics and Telecommunication/Electronics and communication Engineering/ Bio medical Engineering from AICTE/ UGC recognized Engineering College/ university with one-year experience in the relevant field

Diploma (Minimum 2 years) in Electronics/ Electronics and telecommunication/ Electronics and communication/ Bio medical Engineering from AICTE/recognized board of technical education or relevant Advanced Diploma (Vocational) from DGT with two years' experience in the relevant field.

OR

NTC/NAC passed in the Trade of “IoT Technician (Smart Healthcare)” With two years' experience in the relevant field.

Relevant Regular / RPL variants of National Craft Instructor Certificate (NCIC) under DGT.

Maximum emolument paid to any GF must not exceed the ceiling of Rs.30, 000/- during any calendar month.
